WisdomTree Quality Dividend Growth Family

The WisdomTree Quality Dividend Growth ETFs (exchange traded funds) seek long term capital appreciation by investing primarily in high quality, high profitability, dividend-growing companies that meet WisdomTree's ESG (environmental, social and governance) criteria. By focusing on quality stocks, the ETFs aim to provide both upside participation in bull markets, and defensive characteristics during drawdowns along with exposure to leading dividend growers.

WisdomTree Investment Philosophy

At WisdomTree, we believe that quality stocks are the cornerstone of an equity portfolio. They are key to building resilient portfolios that can help investors build wealth over the long term and navigate the inevitable storms along the way.



All-weather investment

The ETFs focus on profitability and medium-term growth to select stocks, creating a portfolio with an asymmetric risk profile: a high upside capture ratio combined with a lower downside capture ratio



Robust, research-driven, systematic process

The ETFs deliver consistent high exposure to the profitability factor with high active share (circa 70%).

Why invest in Quality stocks? Because they have the potential to both grow over the long term and to weather any temporary storm

1. A recognised Investment philosophy

Like Warren Buffet, Benjamin Graham or Robert Novy-Marx, many practitioners have used quality attributes to select stocks in their portfolios.

2. Long Term historical outperformance

Academics have demonstrated that quality stocks have outperformed the market over the long term while exhibiting lower volatility. In 2014, Fama-French extended their three factors model to add quality metrics like operational profitability.

3. An all-weather, balanced risk profile

Quality stocks are attractive on two distinct levels. First, since quality companies generate high revenues, they can grow and compound wealth in the future. Second, thanks to their solid business models and financial strength, they can withstand unexpected events such as an economic downturn or a pandemic.

Quality investments leverage the fact that quality stocks can grow over the long term and weather any temporary storm. This makes quality an ideal candidate for a strategic, long term, core investment in equities but also for a prolonged period of uncertainty where a bear market rally or a deep drawdown are as likely.

WisdomTree ESG framework

WisdomTree understands the importance of ESG considerations within investment strategies and strongly believe that ESG principles need to be addressed holistically and not simply applied to a subset of impact investments.

We have aligned our proprietary equity indices with ESG factors using exclusion criteria, applying a combination of principle-based exclusions and activity-based exclusions based on the assessment from Sustainalytics, a leading independent ESG and corporate governance research, ratings and analytics firm;

Investment process

With the Quality Dividend Growth strategies, investors benefit from WisdomTree's style-consistent, transparent and systematic investment process, which is rooted in academically driven research.

I Screening for Inclusion

- + **Liquidity and Dividend Screen** – Only dividend-paying companies with a dividend coverage ratio of at least one and minimum market capitalisation as well as average daily volume to ensure liquidity are eligible.
- + **Composite Risk Score** - uses Quality and Momentum scores to rank companies and separate the strongest from the riskiest companies. The riskiest companies, as well as potential value traps, are screened out.
- + **ESG Considerations** - Index members are also screened for the ESG (Environmental, Social, and Corporate Governance) criteria defined within the WisdomTree ESG framework.

II Stock Selection

Each strategy comprises a diversified basket of companies with the best combined score using three fundamental metrics¹ that we believe best represent high-quality companies:

- + Return on assets (ROA)²
- + Return on equity (ROE)^{2,3}
- + Analysts' earnings growth expectations⁴

III Weighting

- + Annual Rebalancing
- + “dividend stream” weighting - the weight for each stock is derived from the amount of dividend paid by the company over the previous 12 months in US dollar terms (Dividend per Share x # Shares Outstanding).
- + This weighting methodology allows to take into account the size of the company and to control for the valuation of the portfolio by ensuring that the strategy is not focusing on overpriced stocks.

3 In the WisdomTree US Quality Dividend Growth strategy, and the WisdomTree UK Quality Dividend Growth strategy, companies with negative equity and therefore undefined return on equity will be given a median score as long as they've shown dividend growth over the past five years.”

4 In the WisdomTree UK Quality Dividend Growth strategy, this is combined with EBITDA and Sales growth.

- + **Diversification:** Individual Stock caps as well as country and sector caps to ensure diversification. In the WisdomTree Global Developed ex-US Quality Dividend Growth Index and WisdomTree Eurozone Quality Dividend Growth Index, country weights and sector weights are capped and floored to ensure that the maximum deviation from the starting universe⁵ is limited to 5%, 10% respectively.
